The National Insurance Crime Bureau and the National Equipment Register reveal the cost of construction site crime to be between \$300m and \$1b annually.

Less than 25% of stolen construction materials are ever recovered.

The most commonly stolen items from construction sites are copper (and other metals), lumber, small/hand tools, power tools, and heavy machinery.

Most thefts occur in laydown areas or where the equipment spends most of its time. A high volume of theft occurs in areas without security coverage.


